## **Certified Payroll Solution**

If you are a contractor or subcontractor working on construction projects covered by Federal Davis-Bacon Regulations, you'll be interested in checking out Certified Payroll Solution, because it will make your reporting requirements easier.

In addition, the EEOC Report Form 1392-A is also included with the program.

The product is easy to use and contains very detailed information about setting up QuickBooks, so that you'll easily be able to generate the appropriate certified payroll forms.
